### CIRCULAR TO PARENTS - CLASSES X AND XII 2025-26

#### Verification and Correction of Student Data in CBSE LOC (X & XII) – Session 2025–26

Dear Parents and Students,  
Greetings from Indian School Muscat !

The Central Board of Secondary Education (CBSE) has informed that the **correction window for the List of Candidates (LOC)** for Classes X and XII for the academic session 2025–26 will remain open from **13<sup>th</sup> October 2025 to 27<sup>th</sup> October 2025**.

In accordance with the CBSE circular, parents are requested to carefully review all particulars submitted for their ward in the LOC. CBSE has clearly mentioned that **no corrections will be permitted after the closure of this window**.

Please note the following points and ensure necessary verification from your end:

1. Check whether the **personal data of your ward**, i.e., name, date of birth, mother's name, and father's name, has been correctly filled in the LOC.
2. **All names with the expanded form** have been filled in and not in short names. This may be an issue in future, as in many places, details in extended(full) form are required.
3. The **surname** has to be given in case your ward is planning to study abroad, as this is the requirement of several countries.
4. The **date of birth** is correct in all respects.
5. While submitting the data, **the details given in the latest passport of your ward** have also been checked.
6. **Subjects** have been filled in with due care in the LOC of both classes X and XII , as **no changes will be accepted after the correction schedule closes**.
7. **It is the responsibility of the parents that all the data of their ward submitted in the LOC is correct.**

A copy of the LOC will be shared by the class teacher. You are requested to verify the details, sign, and return the same to the class teacher by **23<sup>rd</sup> October 2025**. Please note that no requests for correction will be entertained after **23<sup>rd</sup> October 2025**.

Your cooperation in this verification process is essential to ensure accuracy in your ward's CBSE examination records.
