### INDIAN SCHOOL MUSCAT CLASS XI – ADMISSION CRITERIA

**(Applicable only for the existing class X students of Indian School Muscat)**

Only 40 students will be admitted in each of the classes. Kindly note that admission to Class XI will be done only after Class X Board results and shall be based on merit i.e. percentage of marks. The given criteria are only the minimum percentage of marks for registration to a particular stream. However, priority will be given to those students who secure higher percentage of marks.

Admission to Engineering Graphics, Computer Science, Informatics Practices and Mathematics groups will be strictly based on merit as the school has limited seats, i.e. 40 seats only.

Students seeking admission to Humanities Stream need to have the minimum pass marks subscribed by CBSE, i.e. 33% marks in each of the subjects in Class X.

There should be a minimum of 15 students to start a stream. If the number of students is insufficient for a particular stream, that stream will not be started.

**The Provisional Admission to Class XI will be on the basis of the Average of the best two marks from the half yearly exam and two Pre-Board Examinations conducted in Class X during the academic year 2024-25.**

### Sports & ECA Quota

We wish to recognize the contributions made by our students in the field of Sports & Games and other Extra Curricular activities (ECA) by awarding some weightage for their contribution. The details of the criteria taken into consideration are as follows:

One seat is reserved for sports students in each section of Class XI and this seat will be allotted to the deserving student on the basis of the following criteria:

- The student should have minimum of 40% marks in each of the subjects without moderation.
- He/she should have won at the cluster level (inter school) when he/she was in Class IX / X or represented Oman and National Level Team.

There shall be seats reserved for ECA and Sports in form of seat 10% (rounded off) (6% for sports, and 4% for other ECA) of total seats. The following relaxation in terms of marks will be given:

**Kindly note that any student who has represented the National team will be given stream of his/her choice subject to Board results.**

- Relaxation shall be applicable with regard to all minimum percentage criteria fixed viz. subject & aggregate.
- Only those students deputed by the school for the events/disciplines shall be considered. Individual performances in disciplines outside ISM structure shall not be given weightage.
- Only the performance in Class IX / X at ISM will be considered. No weightage shall be given to a candidate who has not studied in ISM in Class X. However, candidates coming from India may be considered with regard to their performance at Zonal/National level subject to submission of verifiable valid documents. Only the highest level of performance will be considered.
