Dear Parent,

Sub:- Fee concession for 2019-20 and financial support to deserving parents.

Please note that no application forms will be accepted after 8<sup>th</sup> May 2019. The decision to grant fee concession is purely at the discretion of the School and the decision will be based on the merit of the application with relevant supporting documents.
