### Mandatory Safety Guidelines:

- CCTV systems to monitor students and drivers (with recording facility).
- Seat belts for all seats as per the approved seating capacity.
- IVMS (In-Vehicle Monitoring System) is available for parents.
- Air-conditioning systems with adequate cooling.
- Fire extinguishers, proper horn, emergency exits, and rear-view mirrors.
- Availability of a spare tyre, first aid kit, and automatic door-closing systems.
- Presence of a trained assistant/helper on board.
- Strict adherence to approved seating capacity in compliance with ROP.
- Valid insurance coverage as per vehicle registration and seating capacity norms.

Parents may kindly contact the operators directly and finalise the most appropriate option based on their location and requirements. Kindly note that the selection of the transport operator and payment of fees will continue to be a direct arrangement between the parent and the operator.

The School remains committed to safety and well-being of all students and to strengthening safety oversight, and will continue to engage with relevant authorities and stakeholders in promoting safety awareness and responsible practices. Parents are encouraged to independently verify safety measures and ensure that appropriate standards are maintained when using any transport service.
