5. What are isotopes? Give examples. 1

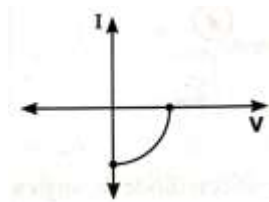

7. Write the relationship between the size of a nucleus and its mass number. 1

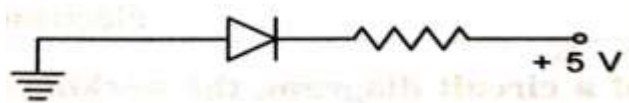
8. Name the junction diode whose I-V characteristics are drawn below. 1

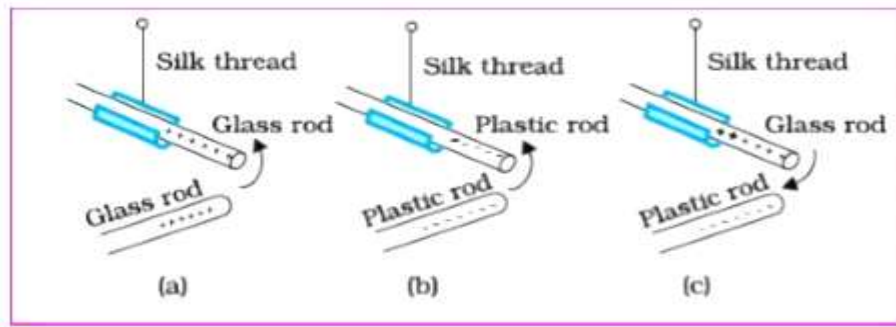

11. Assertion (A): Electric field at the surface of a charged conductor is always normal to the surface at every point. 1

### SECTION-B

**Questions 15 and 16 are Case Study based questions and are compulsory. Attempt any 4 sub parts from each question. Each question carries 1 mark.**

15. When a glass rod is rubbed with silk, the rod acquires one kind of charge and the silk acquires the second kind of charge. This is true for any pair of objects that are rubbed to be electrified. Now if the electrified glass rod is brought in contact with silk, with which it was rubbed, they no longer attract each other. They also do not attract or repel other light objects as they did on being electrified. Thus, the charges acquired after rubbing are lost when the charged bodies are brought in contact. What can you conclude from these observations? It just tells us that unlike charges acquired by the objects neutralize or nullify each other's effect. Therefore, the charges were named as positive and negative by the American scientist Benjamin Franklin. We know that when we add a positive number to a negative number of the same magnitude, the sum is zero. This might have been the philosophy in naming the charges as positive and negative. By convention, the charge on glass rod or cat's fur is called positive and that on plastic rod or silk is termed negative. If an object possesses an electric charge, it is said to be electrified or charged. When it has no charge it is said to be electrically neutral. 4

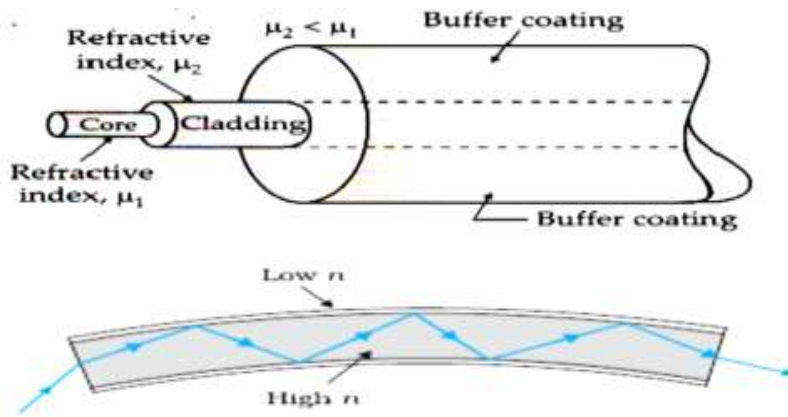

16. Optical fibres: Now-a-days optical fibres are extensively used for transmitting audio and video signals through long distances. Optical fibres too make use of the phenomenon of total internal reflection. Optical fibres are fabricated with high quality composite glass/quartz fibres. Each fibre consists of a core and cladding. The refractive index of the material of the core is higher than that of the cladding. When a signal in the form of light is directed at one end of the fibre at a suitable angle, it undergoes repeated total internal reflections along the length of the fibre and finally comes out at the other end. Since light undergoes total internal reflection at each stage, there is no appreciable loss in the intensity of the light signal. Optical fibres are fabricated such that light reflected at one side of inner surface strikes the other at an angle larger than the critical angle. Even if the fibre is bent, light can easily travel along its length. Thus, an optical fibre can be used to act as an optical pipe.

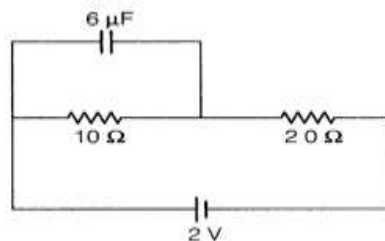

- (a) Derive an expression for the electric field  $E$  due to a dipole of length ' $2a$ ' at a point distant  $r$  from the centre of the dipole on the axial line.
- (b) Draw a graph of  $E$  versus  $r$  for  $r \gg a$ .
- (c) If this dipole were kept in a uniform external electric field  $E_0$ , diagrammatically represent the position of the dipole in stable and unstable equilibrium and write the expressions for the torque acting on the dipole in both the cases.
